Dr. Pradeep.M.S., Member Secretary welcomed the Chairman & members of the Committee and discussed about the protocols submitted by Dr. Keshavamurthy.R., Dr. Ninad Chandrakanth Tamboli & Dr. Shivakumar.V. on turn.

Dr. Keshavamurthy.R., & his associate Dr. Prathibha Ranganathan explained about their study namely "MOLECULAR PROFILING OF TUMOR STROMA (CANCER ASSOCIATED FIBROBLASTS)-NOVEL STRATEGIES TO COMBAT THERAPEUTIC RESISTANCE IN CANCER" & another study for extension namely "UNDERSTANDING THE MECHANISM (GENE EXPRESSION SIGNATURES) OF EMERGENCE OF CASTRATE RESISTANT PROSTATE CANCER. The committee members raised some points of doubts about the subject matter which were clarified by them. Further, the committee insisted to correct the investigator name in the Certificate which was issued by Research Review Committee &

also insisted to submit the progress reports. After the discussion, the committee unanimously approved both the studies & instructed to submit the corrected copy of RRC Certificate. The corrected RRC Approval Certificate was submitted before the committee immediately.

Protocol submitted by Dr. Ninad Chandrakanth Tamboli " TO STUDY QUALITY OF LIFT (QoL) IN PATIENTS WITH UROLITHIASIS USING PATIENT REPORTED OUTCOME MEASUREMENT INFORMATION SYSTEM (PROMIS)" was reviewed & discussed. After the discussion, the committee unanimously approved the study.

Dr. Shivakumar.V., has explained his study "A COMPARITIVE STUDY OF BLIND V/S ULTRASOUND GUIDED OBTURATOR NERVE BLOCK IN TURBT-A RANDOISED PROSPECTIVE STUDY. The Committee members raised some points of doubts about the subject which was clarified by him. But, the committee was of the opinion that the proposal was not submitted in the correct format & also the documentation was incomplete. Hence, the committee unanimously decided that proposal should be re-submitted by the Principal Investigator in the prescribed format along with required documents. The resubmitted proposal will be considered in the next IEC meeting.
