2. Scope of Work:

- Maintenance of Garden by Daily watering, weeding Cleaning ,and seasonal Pruning application of Red Earth sand Manur and Plant Protection Chemicals

- Eligibility Criteria

- Any reputed and financially sound individual Firm/agency, having suitable technical financial and managerial capabilities satisfying, Manure and Plant Protection Chemicals etc.,

3. Qualification Information:

- a) To qualify for award of this contract, each Tenderer in his name should have done similar Landscaping and Maintenance Works in the department of Horticulture / BBMP / BDA / Nursery men Co-op Society or any other Govt departments / Boards / under taking with a mandating satisfactory completion as a prime contractor for at least one similar work. [Landscaping & Maintenance Work]
- b) Tenderer should furnish the information and documents in respect of similar landscape work done supported by necessary certificates from competent authority. If Authority desires, physical verification will be done for previous work done.

4. Even though the Tenderers meet the above criteria, they are subject to be disqualified if they have:

- Made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirement: and / or
- Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.

5. INSTRUCTIONS :

- A) Bidders/Contractors Should attach all the copies of certificates pertaining to their eligibility criteria qualification information documents which the bid will not be considered.
- B) A successful tenderer will have to execute an agreement as per standard document for procurement of works.
- C) **Performance Security:** Within 20days of the receipt of the letter of acceptance, the successful tenderer shall deliver
- D) The work shall be commenced with all earnestness within seven (7) days from the date of issue of work order, failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency.
- E) The bidder should periodically complete the seasonal work within stipulated period of time and Maintain the Garden regularly till end of contract.
- F) After satisfactory completion of works as per estimate details the bill should be submitted in triplicate for payment.
- G) **Certificates :** The contractor shall enclose / attach all the necessary certificates duly attested by the employer
- H) The Director, Institute of Nephro-Urology, Bangalore reserves the right to accept / reject any or all tender without assigning any reasons.

f. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the quotation process and reject all quotations at any time prior to the award of the contract.
